### I. Call to Order and Flag Salute

### V. Superintendent's Report

1. <u>Enrollment</u> – Mr. Suarez discussed current year enrollment. We are currently at 665 students.

### 2. Curriculum and Instruction

- 1. Facilities/Maintenance:
  - A. Zoning Officer Kellen Chapin is going to meet with the zoning officer from Rockaway Borough to review the plans this week.
  - B. Long Range Facilities Plan Kellen Chapin made some revisions and will re-submit the plan.
  - C. Lincoln School Fire Doors During the creation of the 2009-2010 budget, the Board allocated \$50,000 for the installation of two to three sets of fire doors at the Lincoln School, but this money maybe used for the installation of the bathrooms in the modular. Mr. Suarez said the hopes to use the Stimulus Money for the bathrooms, but we need to get approval before we can. If the Stimulus Money cannot be used, Mr. Suarez pointed out that the Board maybe able to use money from our Capital Reserve Account, but this needs to be approval by the County Office.

- 2. Modular Canopy Mr. Hurley told the Board it would cost \$24,741. The Board decided not to have a canopy installed.
- 3. Board and District Goals for 2009-2010 Mr. Suarez and the Board discussed goals.
- 4. Stimulus Money Mr. Suarez distributed the submitted application and discussed the content with the Board.
- 5. Curriculum Mr. Suarez discussed our curriculum with the Board and suggested having staff work at revising it over the summer.
- 6. Non-Association Salary Increases Mr. Suarez suggested approving the 2.5% salary increase for those that are not in the association.

- b. Speech Therapist Mr. Suarez informed the Board that interviews are being conducted.
- c. Gifted and Talented Mr. Suarez discussed the future of the position.
- d. Resignations Mr. Suarez informed the Board that Ms. Katy Haire and Ms. Jessica Syros have resigned.
- e. Summer Custodian Mr. Suarez told the Board that the third summer custodian, Joseph Dodd, is also the son of the Morris Hills Regional High School Superintendent, Ernie Palestis.

The LEA will receive an estimated \$3,000.00 rebate on annual food purchases which will be reflected as a credit on the monthly statement for purchases for that month.

#### D. Miscellaneous

1. The Board of Education of Rockaway Borough School District goes on record as opposing Senate Bill #1882.

WHEREAS, this bill permits municipalities to transfer responsibility of hiring adult crossing guards for the local school district and any charter schools within the municipality; and

WHEREAS, this bill passes on not only a finacial burden, but also takes public safety responsibility away from trained personnel in local police departments and transfers that responsibility to school districts which do not have the expertise or personnel to handle this responsibility; and

WHEREAS, school districts are currently limited to a 4% increase in their annual revenue; and

WHEREAS, we believe this issue of safety and security clearly rests with the local municipality and the local police force; be it

RESOLVED, that the Rockaway Borough School District strongly opposes and encourages members of the New Jersey Senate and Assembly to oppose Bill #1822.
