July 20, 2009

I. Call to Order and Flag Salute

The meeting was called to order at 7:31 p.m. by Board President, Eileen Haynes.

II. Notice of Announcement

In accordance with the Open Public Meetings Act, the Rockaway Borough Board of Education has provided adequate written notice of the time, date and place of this meeting to the Daily Record and The Citizen.

III. Roll Call

Administration Present: Superintendent of Schools, Emil J. Suarez, Thomas Jefferson School Principal, Patrick Tierney and Business Administrator/Board Secretary, Joseph P. Hurley Jr.

IV. Discussion Items

1. Board and District Goals – Mr. Suarez and the Board discussed Board and District Goals for the 2009 – 2010 school year.
2. Stimulus Funding – Mr. Suarez discussed the possibility of using the funding for special education aides and professional development.
3. Facilities Review Committee – Mr. Suarez and the Board discussed objectives for the committee.
4. School Board Conference – Mr. Hurley asked the Board if they would be interested in attending the New Jersey School Board Conference in October. The Board said no.
5. Board Vacancy – Mr. Suarez and the Board discussed the procedure for filling the vacancy.
6. Keller Avenue Road Work – The construction company has asked to store vehicles and materials behind the Thomas Jefferson School. Mr. Suarez told the company they need to sign a waiver and include us on their certificate of insurance.
7. Maintenance:
 - a. Modular – The modular updates are slated to begin next week.
 - b. Thomas Jefferson School Canopy – The canopy is being stripped and re-painted.
 - c. Summer Maintenance – Mr. Hurley reported that we are on schedule.
 - d. Playground Mulch and Maintenance – Mr. Hurley discussed the conditions of the swings and the amount of mulch required for the playground. The Board asked Mr. Hurley to remove the swings for the Thomas Jefferson School and leave the swings at the Lincoln School.
8. 2009 – 2010 Preschool Tuition Rate – Mr. Hurley discussed increasing the preschool tuition rate with the Board. The Board decided to increase tuition 4% to \$9,767.00.
9. Hourly Wage Increase – Mr. Suarez discussed increasing the hourly wage of Karen Nedo, Diane Miller and Morgan Abrams from \$14.00/hr to \$14.35/hr.
10. Finesville Institute for Innovative Teaching – Mr. Suarez discussed the program with the Board. It will cost \$19,550.

Curriculum and Instruction

3. Ms. Alpaugh and Mr. Tierney are finalizing school schedules with Ms. Johnson teaching half time computers and half time gifted and talented.
4. The State Board of Education adopted a resolution setting new achievement standards in mathematics and language arts literacy (NJ ASK) in grades three and four. The action mirrors similar action taken last year for the NJ ASK after the new tests were administered last year to students in grades 5-8.

Legislative News

1. Senate Bill # 1882 – permits municipalities to transfer responsibility of hiring adult crossing guards to school districts has not yet been voted on. The legislature may take this up after their summer recess.

Other Items

1. The County Health Department has scheduled a meeting for August to prepare for a fall outbreak of H1N1.
2. There will be a discussion on using schools as immunization centers if need arises.
