I. Call to Order and Flag Salute

The meeting was called to order at 7:30 p.m. by Board President, Tim Rogers.

II. Notice of Announcement

III. Roll Call

Board Members Present: Christa Smith, Vice-President, Debbie McNally and Board President, Tim Rogers.

Board Member Absent: Eileen Haynes and Laura Lugo

Administration Present: Superintendent of Schools, Dr. Patrick Tierney and Business Administrator/Board Secretary, Joseph P. Hurley Jr.

IV. Superintendent's Report

- 1. <u>New Hires</u> Dr. Tierney discussed the new employees with the Board.
- 2. <u>Facilities:</u>
 - a. Dr. Tierney informed the Board that the Thomas Jefferson School is almost ready and that Lincoln should be done by the time school begins.
 - b. Dr. Tierney discussed the fire escape repairs.
- 3. <u>AD HOC</u> Dr. Tierney informed the Board that they must create an AD HOC committee must be created to decide how to accommodate the students that are in the modular. Dr. Tierney will look for volunteers.
- 4. <u>State Aid</u>– Dr. Tierney and Mr. Hurley informed the Board that they are receiving \$72,634, not \$145,269 that was reported in July. Dr. Tierney and Mr. Hurley recommended not using the additional state aid to make several teachers full time because there is no guarantee the funds will be part of next year's state aid. If they were to be brought back to full time status and the funds were not available, they would be brought down to part time again. The Board agreed.
- 5. <u>End of the year financial report</u> Dr. Tierney and Mr. Hurley discussed the end of year financials with the Board. They reported that we ended the year with roughly \$223,000 surplus. Of this amount \$175,000 will go into capital reserve for the future facility projects, such as classroom doors and bathroom updates at the Lincoln School. The remaining \$50,000 will go back to the will be used to offset the next year's tax levy.
- 6. <u>School Boards Convention</u>– Dr. Tierney informed the Board that the convention is October 24 – October 26 in Atlantic City.
- 7. <u>Third and Sixth Grade Re-registration</u> Dr. Tierney reported on the progress.
- 8. <u>Additional Board Meeting</u> Dr. Tierney told the Board that there is no reason to have an additional meeting in August.

WHEREAS, The statute also requires members to undergo criminal history background checks and to pay the cost of such investigations; and

WHEREAS, Assembly Bill 444 permits local boards of education to reimburse individual members for the cost of criminal history background investigations; and

WHEREAS, State law (N.J.S.A. 18A:12-4) prohibits the compensation of local board of education members; and

WHEREAS, Members of the Rockaway Borough Board of Education devote significant time and substantial effort to the governance of the district's public schools; and

WHEREAS, The Rockaway Borough Board of Education believes that individual school board members, who are uncompensated, should be reimbursed for the cost the criminal history background investigations, which are necessary to continue serving in office. So, therefore be it

RESOLVED, That the Rockaway Borough Board of Education authorizes reimbursement of individual members for the cost of the criminal history background investigations required by Assembly Bill 444; and be it further

RESOLVED, That the Rockaway Borough Board of Education through its policy adoption process will add the following language to its Bylaws at File Code 0142, "Qualifications and Requirements of Board Members," Clause I:

He/she has not been disqualified due to the conviction of a crime or offense listed in <u>N.J.S.A</u>. 18A:12-1. In order to fulfill this requirement:

Each member of the board of education, within 30 days of the election or appointment to the board shall undergo a criminal history background check investigation for the purpose of ensuring that the member is not disqualified for membership due to a conviction of a crime or offense pursuant to the statute listed above; and

The board shall reimburse the member for the cost of the criminal history record check, including all costs for administering and processing the check. ******

And be it further

RESOLVED, that a copy of Bylaws File Code 0142 as proposed for amendment be attached to this resolution. **
